It does not include betting offices or pay day loan shops - these are now classed as "sui generis" uses (see below) | A1, where there is a display window at ground floor level; A1 or A2 & up to 2 flats; Temporary (2 years) to A1, A3 or B1; C3*; A3*; D2*. |
| A3 Restaurants and cafés: | For the sale of food and drink for consumption on the premises - restaurants, snack bars and cafes. | C1 or C2; Temporary (2 years) to A1, A2 or B1. |
| A4 Drinking establishments: | Public houses, wine bars or other drinking establishments (but not night clubs) including drinking establishments with expanded food provision. | A3; AA. |
| A5 Hot food takeaways: | For the sale of hot food for consumption off the premises | A1, A2 or A3; Temporary (2 years) to A1, A2, A3 or B1. |



| B1 Business: | Offices (other than those that fall within A2), research and development of products and processes, light industry appropriate in a residential area. | B8; B1(a) to C3*; Temporary (2 years) to A1, A2 or A3; State funded school or nursery*; B1(c) to C3* (made between 1 October 2017 - 30 September 2020). |

| C2 Residential institutions: | Residential care homes, hospitals, nursing homes, boarding schools, residential colleges and training centre. | State funded school or nursery*. |
| C3 Dwellinghouses | C3(a) Use by a single person or a family (a couple whether married or not, a person related to one another with members of the family of one of the couple to be treated as members of the family of the other), an employer and certain domestic employees (such as an au pair, nanny, nurse, governess, servant, gardener, secretary and personal assistant), a career and the person receiving the care and a foster parent and foster child. | C4. |

D2 Assembly and leisure

Cinemas, music and concert halls, bingo and dance halls (but not night clubs), swimming baths, skating rinks, gymnasiums or area for indoor or outdoor sports and recreations (except for motor sports, or where rearms are used).

Sui Generis**

(Betting offces and Pay Day Loan Shops)

Certain uses do not fall within any use class and are considered 'Sui Generis'. Such uses include; betting offices / shops, pay day loan shops, theatres, houses in multiple occupation, hostels providing no significant element of care, scrap yards. Retail warehouse clubs, nightclubs, launderettes, taxi businesses, amusement centres and casinos.

A1, A2, A3 or D2*; A1 & up to 2 acts (if a display window at ground floor level); A2 & up to 2 flats Betting Offices and Pay Day Loan Shops & up to 2 flats; C3*; Temporary (2 years) to A1, A2, A3 or B1.
